Presence and ownership of the data files:

Requirement to provide personal data:

All fields marked with "*" must be filled out. In case the user does not fill them out, **Okaaspain** is relieved from registering the user, or managing the service or processing the appropriate order.

Data processing for the management of the website:

The processing of personal data and other information will be limited to that which may be needed for:

- a. Managing communications and requests of the website user.
- b. Managing and ensuring the appropriate operation and provision of services in the website.
- c. Developing, managing, expanding, advertising and promoting the website and its makers.
- d. Performing electronic or remote sales and for the expansion and improvement of the services requested, bought or hired by the user.
- e. Sending information, recommendations and reminders regarding the use of the website and the relationship between this and the users.

Data processing for Okaaspain's commercial research:

For the dissemination and market research of Okaaspain's image, products and services (whether its own or unconnected), Okaaspain may send commercial communications relating to the footwear and textiles; accessories and clothing for babies, children, parents; child safety; children's well-being; child transportation; child hygiene: toys and children's and family leisure; child and family health; child education; issues related to family, children, maternity and paternity.

Expected transfers of data:

Rights of the persons concerned
